



Hall of Fame Induction Policy

1. BACKGROUND

The Constitution of the ATBSO(N) allows for the Board to "announce the awarding of Hall of Fame to a person with outstanding performance to the association events".

2. PURPOSE

This policy has been developed to provide guidance to the ATBSO(N) on the selection of a Hall of Fame inductee of the association.

3. DEFINITIONS

The association means the ATBSO(N).

Member means members of the national body and its state and territories.

Hall of Fame inductee means a member who has been inducted into the Hall of Fame.

4. AIMS

This policy aims to ensure that the Hall of Fame induction is awarded in recognition of achievements in bowling whilst a member of ATBSO N.

5. APPLICATION

This policy applies to all registered ATBSO bowlers.

6. ROLES AND RESPONSIBILITIES

The Board is responsible for:

1. Ensuring that a nomination/s for Hall of Fame membership is consistent with this policy.
2. Awarding Hall of Fame induction to the selected person/s.
3. Receiving nominations and ensuring that the policy process has been followed.

Nominator: The person/s nominating individuals for Hall of Fame induction in accordance with the procedure outlined

Seconder: The person who seconds the nomination of an individual to be inducted into the Hall of Fame

Nominee: A person being nominated, who has excelled at the sport of tenpin bowling, as a member of ATBSO(N) and fulfils the requirements as outlined in 7.3.



7. POLICY PRINCIPALS/GUIDELINES

7.1. General

These guidelines have been approved by the Board consistent with the Association's constitution.

Each completed nomination for consideration is to be forwarded in the first instance to the Secretary of the ATBSO(N) Board:

1. Each complete nomination for induction, including relevant information, is to be forwarded by the secretary of the ATBSO(N) to the Board members.
2. The Board may at its discretion annually elect a Hall of Fame inductee who has excelled in the sport of tenpin bowling whilst a member of ATBSO(N) and has participated as a sportsperson in a manner that has not brought the association into disrepute.
3. The name of each Hall of Fame inductee shall be entered on to the register.

7.2. Election

The selection of a Hall of Fame inductee is recognition by the association of a highly talented sportsperson who has met or exceeded the criteria outlined in this policy.

This honour may be bestowed on a person by the association at any appropriate function.

7.3. Criteria for Hall of Fame

An outstanding sportsperson of the association is a person who has achieved recognition at the highest level in the sport of tenpin bowling within ATBSO N and exemplifies our association values.

For a person to be considered for membership to the Hall of Fame the following criteria must be met:

First and foremost - must have played 150 games or 10 years as a player in Senior's Week Challenge Competitions;

AND named at seniors week as an All Star and won a Masters;

OR be a multiple winner of either the Masters or All Stars.

Note: The Board of Directors will decide the number of Hall of Fame inductions awarded in any one year.

7.4. Procedure for Nomination

Any current member of the Association who wishes to have a person considered for recognition will complete and forward a nomination form to the Secretary.



Hall of Fame Induction Policy

A nomination for selection of a person for Hall of Fame induction shall be made in writing on the attached form and must include all appropriate supporting information. The official nomination is to be forwarded to the Secretary by the 30th June.

Each nomination for Hall of Fame induction shall be endorsed by:

- a) The Nominator, and
- b) A seconder supporting the nomination.

Nomination will include as a minimum; detailed description, including dates etc. of the achievements of the individual as they relate to the criteria for Hall of Fame induction. It should include details of an individual's bowling achievements both within and outside of ATBSO. A chronology of the individual's contribution to the sport should also be outlined. (It is expected that the details provided will form the basis of the speech that will be given when the individual is recognised for their achievement.)

Note: Failure to provide a detailed description of a person's achievements will result in the nomination not progressing to review until one is provided.

7.5. Procedures for awarding Hall of Fame Membership

All nominations for Hall of Fame induction will be reviewed annually by the Board for consideration and recommendation. A sub-committee consisting of two Board members and two existing Hall of Fame members will review nomination/s and make a recommendation to the Board on any nomination received.

The sub-committee will conduct their review in accordance with the criteria outlined. The sub-committee will make recommendations to the Board as a result of their deliberations.

The Board will review the recommendations and by way of a vote approve or reject each recommendation. Election to Hall of Fame induction shall be by a majority of Board members.

Hall of Fame induction will be awarded to the selected member/s at the Senior Week dinner or another appropriate function.
